

MINUTES AND PROCEEDINGS OF A REGULAR MEETING OF THE BUTLER COUNTY BOARD OF SUPERVISORS HELD ON SEPTEMBER 4, 2018.

Meeting called to order at 9:00 a.m. by Chairman Greg Barnett with members Rusty Eddy and Tom Heidenwirth present. Also present were Engineer John Riherd and Jane Close, New Hartford, Iowa.

Minutes of the previous meeting were read and approved as read.

Moved by Barnett, second by Eddy to accept the recommendation of Engineer Riherd and approve a Utility Permit for Aureon Network Services to install fiber optic cable at Birch Ave and Highway 57. All ayes. Motion carried.

Moved by Barnett, second by Heidenwirth to accept the recommendation of Engineer Riherd and approve a Utility Permit for Mid-American Energy to rebuild transmission line along C33 East of Clarksville. All ayes. Motion carried.
