

MINUTES AND PROCEEDINGS OF A REGULAR MEETING OF THE BUTLER COUNTY BOARD OF SUPERVISORS HELD ON DECEMBER 4, 2018.

Meeting called to order at 9:00 a.m. by Chairman Greg Barnett with member Tom Heidenwirth present. Member Rusty Eddy was absent. Also present were Engineer John Riherd, Emergency Management Coordinator Chris Showalter, Sheriff Jason Johnson, Assessor Michele Shultz, Treasurer Vicki Schoneman, Zoning Administrator Misty Kroeze, Director of Veterans Affairs Tom Heckman, Executive Director of Butler/Grundy Development Alliance Jeff Kolb and Jeff Reints, Shell Rock, Iowa.

Minutes of the previous meeting were read and approved as read.

Public hearing was held to consider Resolution Approving Amendment to the Future Land Use Map. Present were Engineer John Riherd, Emergency Management Coordinator Chris Showalter, Sheriff Jason Johnson, Assessor Michele Shultz, Treasurer Vicki Schoneman, Zoning Administrator Misty Kroeze, Director of Veterans Affairs Tom Heckman, Executive Director of Butler/Grundy Development Alliance Jeff Kolb and Jeff Reints, Shell Rock, Iowa. Auditor reported no written or oral comments were received. Executive Director of Butler/Grundy Development Alliance Jeff Kolb stated that he supported the Resolution. Zoning Administrator Misty Kroeze stated that the Planning and Zoning Commission met on November 29, 2018 and approved and that this would be a tool to grant zoning requests identifying the area for manufacturing purposes. At the close of the public hearing, it was moved by Barnett, second by Heidenwirth to approve the amendment to the Future Land Use Map. Eddy was absent. The Resolution is as follows:

APPROVING AN AMENDMENT TO THE FUTURE LAND USE MAP OF THE BUTLER COUNTY COMPREHENSIVE
PLAN IN ACCORDANCE WITH THE RECOMMENDATION OF THE BUTLER COUNTY PLANNING AND ZONING
COMMISSION**

BE IT RESOLVED by the Butler County Board of Supervisors as follows:

- Section 1. The Butler County Planning and Zoning Commission held a Public Hearing on November 29, 2018 to consider an amendment to the Future Land Use Map of the Butler County Comprehensive Plan Update 2012.
- Section 2. The area shown West of Butler Logistics Park in Section 33, Township 92, Range 15 W is currently shown as Agricultural on said Future Land Use Map.
- Section 3. The Planning & Zoning Commission has made the recommendation that the Future Land Use Map be amended to reflect this area as a potential Commercial/Industrial site.
- Section 4. The Board of Supervisors held its own public hearing on this proposed Future Land Use Map amendment on December 4, 2018.
- Section 5. The Board of Supervisors hereby adopt and incorporate an amendment to the Future Land Use Map to include the area West of Butler Logistics Park in Section 33, Township 92, Range 15W as a potential Commercial/Industrial site.
- Section 6. This resolution shall take effect immediately.

Public hearing was held to consider an application by Reints Farms, LLC to rezone 136 acres located in Section 33, Township 92, Range 15 W from "A-1" Agriculture to "M" Manufacturing. Present were Engineer John Riherd, Emergency Management Coordinator Chris Showalter, Sheriff Jason Johnson, Assessor Michele Shultz, Treasurer Vicki Schoneman, Zoning Administrator Misty Kroeze, Director of Veterans Affairs Tom Heckman, Executive Director of Butler/Grundy Development Alliance Jeff Kolb and Jeff Reints, Shell Rock, Iowa. Auditor reported no written or oral comments were received. Executive Director of Butler/Grundy Development Alliance Jeff Kolb stated that he supported the change. Jeff Reints commented that he submitted request for rezoning on behalf of Butler/Grundy Development Alliance to use to improve marketing. His uncle owns land to the south and is on board with rezoning for industrial growth, as well. At the close of the public hearing it was moved by Barnett, second by Heidenwirth to approve the rezoning and to waive the second and third readings of said amendment. Eddy was absent. Motion carried.

Board met with Treasurer Vicki Schoneman on a request for assignment of a Tax Sale Certificate from Gerald Hobson. Hobson will pay \$296 for certificate assignment, assignment fee and delinquent taxes. Moved by Heidenwirth, second by Barnett to approve said assignment of Tax Sale Certificate. Eddy absent. Motion carried.

Board met with Executive Director of Butler/Grundy Development Alliance Jeff Kolb to consider Home Base Iowa Resolution that would match military veterans with available employment. Moved by Barnett, second by Heidenwirth to approve. Eddy was absent. The Resolution is as follows:

RESOLUTION #916

A RESOLUTION SUPPORTING THE HOME BASE IOWA INITIATIVE

WHEREAS, the Office of the Governor of the State of Iowa has launched a public-private partnership called Home Base Iowa initiative, which is an effort to match military veterans with jobs available across Iowa; and

WHEREAS, the Home Base Iowa initiative consists of two programs, Home Base Iowa Businesses and Home Base Iowa Communities; and

WHEREAS, The Butler-Grundy Development Alliance, as the lead economic development organization serving the county, recognizes there is a workforce shortage in Butler County, and this program will serve as an additional tool to grow the pool of qualified applicants for our employers; and

WHEREAS, The Butler County Veteran Affairs Office provides assistance to all qualifying veterans living in Butler County, and recognizes that this program will serve an additional resource to help attract veterans to our county, as well as assist veterans currently residing here that are looking for employment; and

WHEREAS, the Butler County Board of Supervisors finds that it is in the best interests of Butler County and veterans everywhere to support the Home Base Iowa initiative and adopt this resolution.

NOW, THEREFORE, it is resolved by the Butler County, Iowa Board of Supervisors, as follows:

Section 1. The Butler County Board of Supervisors hereby proclaims its support for the Home Base Iowa initiative and encourages the Butler-Grundy Development Alliance and the Butler County Veteran Affairs Office to take whatever actions are necessary for Butler County to become and continue to be a Home Base Iowa Community.

Section 2. The Board of Supervisors also encourages Butler County businesses to take whatever actions are necessary to become and continue to be a Home Base Iowa Business.
