ORDINANCE TITLE I, NO. 1

AN ORDINANCE REPEALING THE ORDINANCE ADOPTION PROCEDURE:

BE IT ENACTED BY THE BOARD OF SUPERVISORS, BUTLER COUNTY, IOWA:

WHEREAS, the Code of Iowa, Chapter 331, County Home Rule, has established the necessary rules regulating the publication and adoption of County Ordinances; and

WHEREAS, the County using the rules provided by the Iowa Code instead of by a County Ordinance policy provides a constantly current and efficient means of administering government;

BE IT ENACTED BY THE BUTLER COUNTY BOARD OF SUPERVISORS, that Ordinance Title I, No. 1 shall be repealed in its entirety and henceforth Code of Iowa, Chapter 331 shall govern publication and adoption of County Ordinances.
